


Strategic Plan UANIPIO

Transparency of the Appeal Board procedures

- Increase the quality of the activities of the Commission "Ukraine" (TM registration process)
- Introduce alternative disputes resolution procedures (mediation)
- Improve the quality of the evidence base in favor of the legal position of UANIPIO in the court
- Preparation of summaries of court IP practice
- Cooperation with National Security & Defense Council, Asset Recovery & Management Agency, National Agency on Corruption Prevention, Min of Justice regarding the sanctions
- Cooperation with enforcement agencies and relevant international institutions

UANIPIO – High-Quality Platform for IP Dialogue with All Stakeholders

- IP office as a professional platform for business communication with state institutions
- Establishing a proactive dialogue with IP community
- Unlocking the procedure of attestation of new patent attorneys & new approach with the professionalism as a priority
- Providing effective dialogue with all sectors of innovation ecosystem, enlc. science and education
- Initiation communication with IP community on elaborating comprehensive proposals on improving the mechanisms for performing the functions of NIPA

- Develop tools to support innovators and business within the framework of recovery of Ukraine from the consequences of war aggression of the russian federation against Ukraine
- Promote innovation activities in the national security and defense spheres in terms of legal protection of IP
- Active participation in development of the innovation ecosystem of Ukraine and in promotion of national business to European and international markets
- Restoration of the role of the IP office in the activization of inventive activity

- Design projects to raise awareness of the value of IP
- Develop tools for use in awareness raising
- Key role in formation and dissemination of IP culture
- Provide knowledge, training and learning programs for IP authorities (IP Academy)
- Assist the creative industries development as a component of the IP system
- Introduction of legal protection of traditional knowledge and traditional expressions of culture by IP mechanisms in Ukraine
